## Notice to Exhibitors

IMPORTANT - TRANSFERS of dogs from regular classes to Best of Breed Competition (Ch 11, Section 6, AKC Rules) MUST be made to the Show Secretary at least 30 minutes prior to the start of any regular conformation judging at these shows.

Prizes: Trophies, ribbons, and prizes will be awarded in the ring to the person exhibiting the dog who shall be considered the owner or agent. All claims for prizes must be made in the judging ring before the completion of judging and the Show Secretary advised at once of any discrepancy.

PLEASE EXERCISE YOUR DOGS IN THE DESIGNATED LOCATIONS AND CLEAN UP AFTER YOUR ANIMALS!

The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged. The HLRC has no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

Dogs may arrive any time before judging begins. Judging will begin promptly as scheduled. Dogs not required for further judging will be excused.

The Hoosier Labrador Retriever Club, Inc., The Tippecanoe County Fairgrounds, Show Secretary, their agents, employees, etc., assume no responsibility for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs or property, and further assume no responsibility for injury to children.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of the entry fee will be made.
